## **Facility Plan**

In preparing for the upcoming season, EDCC is making a commitment to ensure the health and safety of our guests/participants as well as providing the best possible experience under the current Manitoba Public Health Orders. That commitment will include frequent review of the Return to Play protocols put forth by Skate Canada-Manitoba and Hockey Canada-Manitoba.

## **EDCC Programming and Participant Protocols**

- -All individuals are required to sign in upon entry of the arena
- -All spectators aged 12+ will have to show proof of immunization
- -All bench staff will have to show proof of immunization
- All individuals are required to use the shared health self-screening tool prior to entry into the facility. It can be found at: <a href="http://sharedhealthmb.ca/covid19/screening-tool/">http://sharedhealthmb.ca/covid19/screening-tool/</a>
- There will be signs posted reminding guests and participants to practice physical distancing while in the facility.
- -Proper training and review of all cleaning and sanitizing guidelines established by the Province of Manitoba will be implemented and followed at all times.
- -Hand Sanitizer stations will be setup throughout the building (upon entry/exit, dressing rooms, benches, penalty boxes, lobby, and washrooms. Signs will be used stating its mandatory to use sanitizer upon entry and in any contact areas.
- -Signs will be put up stating the use of proper facemasks is mandatory for all participants, coaches, and spectators while in the facility, including participants and officials to and from their respective dressing rooms. Only exception is while on ice.
- -All high touch areas (doors, handrails, timeclock, etc.) will be cleaned/disinfected in between each user group. Latex gloves will also be available in dressing rooms/bench areas, and for all staff in the facility.

- -There will be signs stating the procedures and guidelines, as well as each user group is responsible to have a communication officer to ensure everyone that uses the facility, knows what the expectations are. The Communications Officer will keep an attendance log to be able to follow up with all personnel being exposed to any possible transmissions.
- -Seating compacities/configurations will be based on complying with the Province of Manitoba's health and safety standards to ensure physical distancing.
- -Physical distancing will be enforced in all washrooms in the facility. They will also be cleaned and sanitized on a regular basis based on the Province of Manitoba's health and safety standards.
- -The water fountain spigot will be shut off and the fountain will be used only as a water bottle filling station. All participants are encouraged to bring their own water bottle filled from home.
- -Participants are asked to only come to the facility 40 minutes before their activity. Dressing prior to arriving is encouraged.
- -Physical distancing is required in all dressing rooms. They will be cleaned and sanitized between each user group. If parents are required to help with skates, helmets etc. there will be seating outside of the room to ensure physical distancing is being followed. It will also help to limit the number of people inside the dressing rooms.
- -Failure to follow these guidelines will result in participants/spectators being asked to leave the facility and may have future access denied.
