FACILITY PROTOCOLS

MASKS ARE MANDATORY FOR EVERYONE

SIGN IN IS MANDATORY FOR EVERYONE

SANITIZING IS MANDATORY FOR EVERYONE

All staff members and visitors (players, coaches, officials, parents/guardians, spectators) must use the Province of Manitoba Online Screening Tool before entering the facility. Furthermore, anyone feeling ill or showing COVID-19 like symptoms must stay home and not enter the facility.

All ice bookings must be made through the Arena Caretaker/Kitchen Coordinator.

All other rentals must be made through the Antler River Recreation Director.

Bookings will be spaced accordingly to ensure that disinfection and cleaning measures are completed between uses.

***** ALL RENTERS/USER GROUPS WILL BE RESPONSIBLE FOR *****

- ensure all updated and relevant information is passed on to everyone within their jurisdiction
- monitoring all relevant updates from the public health authority and from Hockey Manitoba/Canada, Skate Canada and Curl Manitoba
- tracking attendance at all events with a sign in sheet that is legible and includes the names of all coaches/participants/patrons for every event
- after each session/event have the attendance sheets left in the arena at the designated area for 21 days to ensure appropriate public health follow up can take place if a participant is exposed to Covid-19
- ensuring any Covid-19 cases are reported as required by the provincial health authority
- ensure that their team/group is not over the facility capacity in all areas of the facility.

GENERAL

MASKS are REQUIRED throughout the facility. Individuals will be turned away from entering without one unless they have a medical reason with the appropriate documentation.

Physical distancing between you and others is always required. Distance markers have been placed throughout the facility to ensure members of the public are sensibly able to maintain a distance of at least 2 meters (6 ft) from other members of the public within the facility, excluding participants who are playing hockey on the ice.

Guests of the facility will find hand sanitizer throughout the facility for use and guests will be required to use the sanitizer. Guests will also need to follow the arrows on the floor for the flow of traffic as well as the designated seating plans.

Avoid congregating in shared areas such as the lobby, waiting rooms, washrooms, concession area and common areas outside at the ice/plexiglass level.

Each event/session is to have an adult supervisor to ensure physical distancing protocols and traffic flow guidelines are being followed.

Water fountains/filling stations will not be available. All users must bring their own labeled, pre-filled water bottles.

Signage will be visibly marked throughout the facility reminding individuals of physical distancing, traffic flow, capacities, entrances and exits.

ENTRY/EXIT IN FACILITY

- Entrance into the facility will be through the marked doors at the main entrance **ONLY**
- Upon entering into building, all users must use hand sanitizer located in the main lobby and sign in with their respected user group.
- Exits for user groups using the dressing rooms are as follows;
 - ◆ Dressing room 1 – East door between dressing room 1 & 2.
 - ◆ Dressing rooms 2 & 3 – South-east door
 - ◆ Dressing rooms 4 & 5 – North door across from dressing room 4 & 5
 - ◆ Dressing room 6 – East door between dressing room 1 & 2
 - ◆ Ref Room – East door between dressing room 1 & 2
- Exits for all user groups/spectators of the arena area will be through the doors between dressing rooms 1 & 2 on the east wall.
- Exit for events held in the Gymnasium will be the north door within the gym.

- Patrons with Wheelchair Accessible passes will be allowed to enter and exit through the main doors.
- User groups will be allowed to enter the facility 20 minutes prior to their schedule event, except for Senior, Highschool and AAA Hockey participants who may enter 45 minutes before their ice time.
- All user groups will have 15 minutes to vacate the dressing rooms and facility.

- Penalty Box – 1 (if multiples, players may have to serve penalties on the bench)
- Washrooms – 2

ARENA RULES

- No warm-ups will be performed inside the facility
- Dressing rooms will be assigned by facility staff and marked on the wall at entry
- An individual's face mask can be removed while on the ice only
- Showering in the dressing room is not permitted, unless they are the last booking of the day
- Spectators will exit the facility with participants within 20 minutes
- Spitting is strongly discouraged
- One parent or caregiver per child allowed in the dressing room for small children needing assistance with equipment etc. They are to report to viewing area immediately after child is dressed. We encourage you to leave other family members at home when possible.
- Participants are encouraged to come dressed.
- Spectators should only leave their seats to use the washroom or arena concession.

UPPER LEVEL BAR/LOUNGE RULES

- Patrons of the concession will be allowed to stay in the designated Lounge area at the top of the ramp west of the concession window between events/sessions
- Physical distancing of 2 m (6 ft) will be required at all times with a maximum of 10 patrons at each table.

CLEANING/SANITIZING

- Dressing rooms and bench areas will be cleaned and sanitized after each session.
- Hand sanitizer will be available throughout the facility and users are encouraged to use it. Hand sanitizer will be available in all dressing rooms, benches, penalty box, time-keeper box, lobby, seating area and washrooms as well as the staff mechanical room.
- Regular cleaning of high touch areas, hand railings, door knobs, light switches, elevator etc. will be conducted by facility staff after each session. Additional sanitation is welcomed with your own supplies.
- Teams will assist facility staff by encouraging frequent hand washing and hand sanitizing as well as avoiding touching surfaces wherever possible

Concession – will follow the provincial restaurant guidelines.

User Group Protocols – each organization that uses the facility is asked to submit their own COVID-19 protocols outlining their safe operating procedures that must adhere to this document.
