



## **TOWN OF VIRIDEN TUNDRA OIL AND GAS PLACE – ARENA SCHEDULE “B” - HOCKEY/PRIVATE RENTAL**

### **FACILITY RULES AND REGULATIONS**

- All ice bookings must currently be made through the Town Office at (204) 748-2440 or via email at [vrc\\_events@mymts.net](mailto:vrc_events@mymts.net).
- Renters are responsible for the actions of their group, members, and spectators.
- Coaches are to keep a record that is legible and includes the names and phone numbers of coaches, players and spectators using the form provided.
- A complete list of players and coaches must be provided prior to using the facility.
- The facility will be responsible for keeping informed and updated regularly on public safety and cleaning requirements.
- **Renters and participants must follow all requirements under the Self-Isolation Order for Persons Entering Manitoba (see attached), as authorized under The Public Health Act.**

### **FACILITY ENTRY**

- Entrance will be through the marked doors on the main entrance.
- Coaches and Players are asked to arrive at the facility 30 minutes prior to their ice time for immunization screening.
- Coaches and Players are to enter in their designated entrance ensuring that everyone is social distancing.
- Coaches and Players must adhere to all guidelines current to the date of rental as outlined in the current Province of Manitoba’s Public Health Orders and their Provincial Sport Association Return to Play guidelines.
- Upon arrival, all coaches and players are to use the hand sanitizer located in the main lobby.

### **IMMUNIZATION SCREENING**

- Effective Friday, September 3rd, 2021, anyone visiting the arena, walking track, fitness centre or other recreational programming at Tundra Oil and Gas Place, will be required to show proof of immunization along with government-issued photo identification.
- Individuals that do not show proof of immunization will not be permitted to enter the facility or participate in indoor programming unless they fall under an exemption in the provincial public health orders.
- Admission of members of the public to the facility is restricted to the following:
  - A. Persons who produce proof that they are fully immunized;
  - B. Persons who produce proof from the Government of Manitoba that there is a medical reason for the person not to receive a vaccine for COVID-19;
  - C. Persons under 18 years of age.

- The following documents are considered valid proof of immunization in Manitoba:
  - Manitoba Immunization Card
  - National Defence Canada Covid-19 Vaccine Record / Card
  - Canadian Public Health Association (CPHA) Travel Vaccination Record
  - An official document issued by a Canadian province or territory containing information of a person's COVID-19 vaccination history
  - **International travelers:** Immunization documentation submitted to Canadian border service officials and government-issued photo identification that confirms their citizenship
- Self-screening for coaches and skaters must occur before entry into the facility. Please use the online self-screening tool at [sharedhealthmb.ca/covid19/screening-tool](https://sharedhealthmb.ca/covid19/screening-tool).
- Please stay home if you or any of your household members are experiencing any symptoms.

## INSIDE OF THE FACILITY

- Showers are not to be used at this time.
- Water fountains are not available. All users must bring their own labelled, pre-filled water bottle.
- Washrooms will be available with limited capacity.
- No spitting, fighting or blowing noses without a tissue. A zero-tolerance policy will be enforced regarding these actions and individuals failing to comply may be asked to leave the premises and have future bookings suspended.
- Dryland training will be permitted in a designated area, with a capacity of up to 10 participants and one (1) coach physically distanced 2 meters apart.

## MASK USAGE

- Mask usage is mandatory inside the Tundra Oil and Gas Place facility, with the following exceptions:
  - A. On-ice activity, unless the renter's governing organization requires the wearing of masks. If so, that directive must be adhered to.
  - B. A child who is under five (5) years of age.
  - C. A person with a medical condition that is unrelated to COVID-19, including breathing or cognitive difficulties, or a disability, that prevents them from safely wearing a mask.
  - D. A person who is unable to put on or remove a mask without the assistance of another person.
  - E. A person who needs to temporarily remove their mask while in an indoor public place for the purpose of
    - Consuming food or drink
    - An emergency or medical purpose
    - Or establishing their identity
- Staff and volunteers will ensure the use of face masks in the facility.

**Anyone refusing to wear a mask or wear a mask properly may be asked to leave the facility.**

## SOCIAL DISTANCING & SANITIZATION

- Social distancing of 2 metres (6 feet) is required inside the facility.
- Congregating, or standing in hallways or common areas is not permitted.

- Facility staff will implement measures to ensure members of the public are able to maintain a distance of at least two metres from one another. COVID-19 related information will be posted throughout the facility reminding patrons of physical distancing guidelines, hand hygiene and cough etiquette.
- There must be an adult supervisor off the ice making sure physical distancing guidelines and traffic flow are being followed for the entire session.
- High contact surfaces will be cleaned and sanitized by facility staff after each block session. If additional sanitization is desired during your block session – users are welcome to do so.

## **SPECTATORS**

- Spectator capacity is 50%. Social distancing is required.
- Spectators should remain in the stands until all individuals have left the ice to avoid crowds around the gates/exits.
- All spectators are encouraged to leave the facility immediately following the ice session.

## **DRESSING ROOMS**

- All players are encouraged to arrive at the arena dressed in their hockey gear with the exception of skates, helmet and gloves.
- Dressing rooms are available at 50% capacity. Capacity levels will be posted on the dressing room doors. Please indicate the number of players you have when booking your ice time.
- There will be a designated area with physically distanced seats for skaters and coaches to put on their skates. Any players that require assistance with their skates or gear are to come dressed and use the designated chairs to put on skates, helmets, etc.

## **ON-ICE ACTIVITY**

- Individual names and contact information must be provided for all facility bookings prior to access to the facility. For bookings with more than one group, group designations must also be provided. No individuals may change their designated group throughout a booking.
- Full equipment is required for players.
- Players should stagger entering the ice surface from the designated seats.
- Hand sanitizers will be provided for each bench.
- Renter must provide hand sanitizers if players leave the ice surface.

## **EXITING THE FACILITY**

- Players, coaches and spectators must exit the facility no later than 20 minutes after their session. All players and coaches are to remove skates/equipment and leave the facility as quickly as possible so that the areas can be cleaned and sanitized.

## COMPLIANCE

Following of the protocols put in place by the Town of Virden, Hockey Manitoba, Manitoba Junior Hockey League, Hockey Canada and Manitoba Health (including travel restrictions) is of the utmost importance. In order to assure that we can continue to enjoy the Tundra Oil & Gas Place facility, these protocols must be followed.

If protocols are not followed, renters may be suspended from renting the ice for a minimum of 2 weeks.

**The Town of Virden is not responsible for any fines incurred by users or spectators for not following the Manitoba Health Restoring Safe Services Guidelines/Public Health Orders as well as the Return to Play guidelines provided by the User Group's provincial sport body (if applicable).**
